***Achievements***

Students trained: 130 (Farm workers: 71 , Emerging farmers: 59)  
Number of students certified competent: 121  
Courses presented: 8  
Provinces: Limpopo (4), Free State (2), Gauteng (1), Western Cape (1)

***Non-achievements / underperformance***

A total of eight (8) students have not been assessed. Only one (1) student failed the assessment.

***Reasons for non-achievements / underperformance***

Some students did not attend the full programme, including the assessment phase.

***Planned remedies for non-achievements / underperformance***

Note that the farmer is informed regarding students who did not complete the programme due to either reluctance or other valid reasons. Students who failed the test will be re-assessed upon request. Both the farmer and the farmworkers are informed regarding re-assessment policy.

A total of five (5) students have not been assessed.  
A total of eight (8) students failed the assessment.

#### ***Reasons for non-achievements / underperformance***

The students could not be assessed as the required competency level to perform artificial insemination has not been met. The facilitator has discussed the matter with the farmer and they have been informed that re-assessment will take place once the students are ready. These students did not meet the required competency level to perform artificial insemination practices.

#### ***Planned remedies for non-achievements / underperformance***

The IST training manager is coordinating this matter with the farmer. Students who failed the test will be re-assessed upon request. Both the farmer and the farmworkers are informed regarding re-assessment policy.
