#### **Project goals**

**Goal 1 - Review SA representatives on IDF Standing Committees, Work Groups and Action Teams and appoint / re-appoint representatives (Target date: January 2013)**

### **Goal 2 - To ensure that SANCIDF make appropriate and timely inputs to the IDF through the SA representatives on the various IDF Standing Committees**

#### ***Achievements***

All the appointees mentioned in Goal 1 were requested to send their replies to questionnaires to the National- and Technical secretaries so that the replies from SA can be co-ordinated. During the year, replies were sent to IDF on 6 questionnaires and 4 proposals for New Work Items

### **Goal 3 - To make information produced by the IDF (such as standards, bulletins and newsletters) available to the levy payers and the general public**

#### ***Achievements***

**Goal 4 - To provide Milk SA with the titles of standards, bulletins and news briefs as published by the IDF for publication on its website**

***Achievements***

All Bulletins, Standards and Press Release/News briefs were sent by e-Mail to the CEO of Milk SA. The bulletins, Standards and IDF Newsbriefs were also uploaded on to the Milk SA website by the National Secretary.

**Goal 5 - Forward Bulletins and Standards received to members of SANCIDF and the organized dairy industry**

***Achievements***

All Bulletins and Standards received during this quarter were sent to representatives of SAMPRO, MPO and DAFF all of whom are members of SANCIDF and the also comprise the organized dairy industry. (This goal duplicates Goal 3).

***No Non-achievements / underperformance has been reported***

**Goal 6 - To ensure that the general issues are brought to the attention of the IDF**

***Achievements***

The first general issue that was brought to the attention of IDF was to inform them that the Global Feed and Food Congress that was to take place in South Africa, was promoted in The Dairy Mail

Another general issue that occurred is related to a viewpoint on the term soybean milk which was to be discussed at the May meeting of Codex. At the Feed and Food congress, Mr. Joerg Seiffert from IDF requested Mr. Nico Fouche that SANCIDF should request the SA representatives on the Codex Committee to support the IDF position statement on soybean milk namely, that it should be called soybean beverage. The Secretary was tasked to arrange a meeting between industry representatives and SA's Codex representatives. Unfortunately the numerous e mails to the Milk SA CEO to establish who the industry representatives are, did for some reason not reach him until 18 May 2013. The Codex Committee meeting in question took place from 14 – 17 May. On 3 June, Joerg Seiffert informed Mr. Fouche and the Secretary that the SA delegation to the Codex Meeting, did not support the IDF position above.

***Non-achievements / underperformance***

The SA delegation to the relevant Codex Committee meeting could not be put in contact with dairy industry representatives

Subsequent to this turn of events, the SANCIDF Executive Committee decided that all Codex related matters should be referred to Mr Jompie Burger who will discuss such matters with DAFF and Dept of Health

## **Goal 7 - To promote attending the World Dairy Summit (WDS) amongst local dairy industry leaders**

### ***Achievements***

WDS 2013 was promoted in three articles written for The Dairy Mail. Seven News briefs relating to WDS 2013 were circulated to Industry members on the EC as well as to all associate members and Standing Committee members.

## **Goal 8 - To give meaningful feedback of WDS to the local industry**

### ***Achievements***

At its last meeting before WDS 2013, the Executive Committee decided that it would consider the format and date of feedback at its first meeting in 2014. The President and Secretary did however, make presentations about WDS 2013 at the General, Members' meeting of Milk SA held on 15 November 2014. Also, in December an article (in Afrikaans) reporting briefly on WDS 2013 was published in The Dairy Mail.
