3. After the cancellation of WDS 2014, the SANCIDF Executive Committee was offered a sponsorship by a SA dairy company for South Africa to host WDS 2014. IDF was informed of this possibility but after careful consideration by the EC, the risks outweighed the benefits and IDF was informed accordingly.
