**Achievements** 4. Pilot study on the modules of the Dairy Farmworker (Note that Milk SA funding will not be utilized for the pilot study as such, though the IDT personnel will be involved in the piloting ito assessment and re-alignment of learning and assessment material, which are included in the budget): • Identification and orientation of commercial farm and students. Commercial farmer to assist with the streamlining and evaluation of the assessment process and workplace experience. • Presentation of modules. • Assessment of modules. • Practical modules and assessment. • External assessment. • Workplace experience (logbook) evaluation. • Realignment of learning and assessment material, if necessary.

Pilot study will commence once the IDT receive funding from AgriSeta. IDT envisage to start with pilot programme during 2nd quarter.
