Goal 4 - Pilot study on the modules of the Dairy Farmworker

Achievements 4. Pilot study on the modules of the Dairy Farmworker (Note that Milk SA funding will not be utilized for the pilot study as such, though the IDT personnel will be involved in the piloting ito assessment and re-alignment of learning and assessment material, which are included in the budget): • Identification and orientation of commercial farm and students. Commercial farmer to assist with the streamlining and evaluation of the assessment process and workplace experience. • Presentation of modules. • Assessment of modules. • Practical modules and assessment. • External assessment. • Workplace experience (logbook) evaluation. • Realignment of learning and assessment material, if necessary.

The presentation of the pilot study on the modules for the Dairy Farmworker are not coverd by the Milk SA project.

The pilot project is taking place at the farm of Mr Hannes Neetling near Rayton. Initially 10 students participated in the programme but only 6 students are currently involved. The reason for the fall out of students are due to work commitments and leave arrangements.
