Year 2015 (January 2015 till December 2015)

Project goals

Goal 1 - Review SA Representatives on IDF bodies (SC's, AT's etc)

Achievements

With the retirement of Mr. Bertus de Jongh, Ms Christine Leighton was appointed primarius member of the Standing Committee on Marketing and Mr Alwyn Kraamwinkel was appointed sekundus member of the same SC. All other members of SC's are still in place and therefore no review was necessary.

Goal 2 - Ensure appropriate and timely inputs by SANCIDF and SA representatives on IDF bodies to IDF

Achievements

Seven requests for comments were received during this year. They were:

NWI 15-01: ISO 17678 | IDF 202. Milk and milk products — Determination of milk fat purity by gas chromatographic analysis of triglycerides (Reference method) - revision of the scope. Approved 20150306

NWI 15-02: Guidelines for the use of in-line infrared spectrometry. Approved 20150312

NWI 15-03: Provision of background material to indicate the need to apply a potential conversion equation for quantitative determination of bacteriological quality in milk. Approved 20150313 NWI 15-04: Infant formula and adult nutritionals -Determination of total iodine in infant formula and adult/pediatric nutritional formula by inductively coupled plasma - mass spectrometry (ICP-MS)

NWI 15-05: Infant formula and adult nutritionals -Determination of chromium, selenium, and molybdenum by inductively coupled plasma-mass spectrometry

NWI 15/06 A Nutrition Initiative providing FAO with nutrition info at schools. A reply was sent to IDF on 21 July.

Update of review of scientific literature pertaining to Nitrogen Conversion Factor.

We replied to the following New Work Items during 2015:

NWI proposal 15/04: Infant formula and adult nutritionals - Determination of total iodine in infant formula and adult/pediatric nutritional formula by inductively coupled plasma - mass spectrometry (ICP-MS)

NWI proposal 15/05: Infant formula and adult nutritionals -Determination of chromium, selenium, and molybdenum by inductively coupled plasma-mass spectrometry

There were also results of voting. They were:

NWI 15-04: (described above)- 15 countries voted in favor, one abstained and 14 did not reply.

NWI 15-04 (described above) - 16 countries voted in favor, one abstained and 13 did not reply.

That we were not asked for input to the SCDPE country reports and why the National Secretary is not copied on requests to SC members for input.

We informed IDF of our concern regarding the proposed co-operation between IDF and GDP. The main issue of concern was that IDF's standing as representative of the whole dairy industry on International Governmental Organisations (IGO's) like FAO, WHO, OIE, Codex etc. may be jeopardized if GDP represented the dairy industry on the focus areas of Nutrition and Health and Environment

An article on research by University of California indicating a link between infection with a bovine

leukemia virus and human breast cancer.

The National Committee's opinion that now (November 2015) was not the appropriate time to start looking for a new Director General (where the contract of the current DG only expires early in 2017).

Our concern about the increasing number of sustainability organizations viz GDAA, DSF and GSF.

IDF returned acceptable replies to all points.
