Comments (by SCENV member Dr Heinz Meissner):

1. I have previously raised my concern about the relevance and efficiency of our participation in IDF and its FAO associated activities. I was invited to serve on the committee dealing with the LEAP – Water TAG (see Annexure 1). I accepted the invitation on condition that I cannot travel to Rome for Meetings for several reasons, one obviously being funds as committee members are responsible for their own expenses. This then resulted in the invitation being withdrawn and someone else was appointed.

2. Regarding WDS attendance without really making active contributions in committees, I have my doubts whether from an affordability point of view the large contingency of SA representatives are really justifiable. I think attendance should be revisited.
