Achievements

The MPO Institute is continuously working on the promotion and marketing of dairy skills and knowledge development in the industry. The following platforms are being used: The Dairy Mail, MPO weekly newsletter, bulk mobile texting and Facebook advertising and radio interviews.

The MPO has established a database of developing dairy farmers in collaboration with various stakeholders. This database will be used as guideline for future training.

The MPO Institute also commenced with the design and development of various courses that have been identified as industry needs. These courses are being developed as specialised modules additional to the Dairy Occupational Qualification. Surplus funding from 2016 are being utilised for the development of the following modules:

Dairy reproduction management
Bio-security in dairy production

To present the Code of Practice for Milk Producers on all levels of the dairy occupational qualification, a game board are being developed as a learning methodology for farmworkers. The gamification principles applied will help the farm worker to gain insight and understanding of the code of practice concepts without being proficient in English.

A database for training as well as a training prospectus/booklet is still in process of development.
