Project goals

Goal 1 - Implementation of sustainable commercialization dairy programme

Achievements

During the period under review one general meeting was held and two visits per farm were made to each of the eight beneficiaries in Free State and the following have been achieved:

- 1. Farm management record sheets and its importance were discussed and farmers explained how to complete it. Farmers were also informed that record keeping would be a condition to get private veterinary services.
- 2. A local private vet has been given a sheet indicating a list of veterinary services to be supplied to beneficiary farmers and further requested to provide a quotation for veterinary services and he did.
- 3. Our independent, experienced advisor had assessed fodder situation on two farms to determine the number of heifers that could be supplied. The report is being considered.
- 4. Fodder flow situation has been assessed on three farms where cows/ heifers have already been supplied. The objective is to assist each farmer with a fodder flow plan for the whole year.
- 5. Two meetings were held with the milk buyer in order to plan future delivery of cows, ensuring counter performance by farmers and getting feedback on the performance of farmers supplied with cows.
- 6. Eskom quotations for 6 farmers have been revised and concerns regarding unclear information were addressed.
- 7. Farmers have been informed that they would have to pay a deport of R10 500 each and open an account in their names before electricity could be connected. From the date of depositing the connection fee it will take about 120 days to complete the job.
- 8. Old Mutual has a fund called Masisizane Fund, whose purpose is to fund business where the majority of owners are women. An Old Mutual official has been taken to the farmers so that those who needed financial assistance could make arrangements themselves. Currently the officer of Old Mutual is busy compiling a profile of each farmer/farm.
- 9. A follow-up meeting was held with Thabo Mofutsanaya District Municipality to discuss the progress regarding rural electrification programme as they had already requested the list of farmers Milk SA was assisting. It has been report that the matter was discussed with the Department of Mineral and Energy and Eskom An undertaking was made to visit all the farmers that Milk SA had identifies as part of the Sustainable Commercialization Project.
- 10. Farmers have been advised to obtain quotations for heifers and given the names of potential sellers of heifers.

Goal 2 - Transformation Strategic Plan

Achievements

The draft report submitted during the previous quarter is currently being finalized by incorporating inputs form other members of the Board. Following are some of the salient points in the draft report.

Goal 3 - Emerging dairy entrepreneur database

Achievements
