Project goals

Goal 1 - Implementation of sustainable commercialization dairy programme

Achievements

IMPLEMENTATION OF SUSTAINABLE COMMERCIALIZATION DAIRY PROGRAMME
(Effective and efficient implementation of the utilization of surplus funds)

During the period under review one general meeting was held and two visits per farm were made to each of the eight beneficiaries in the Free State and the following have been achieved:

1. Development Bank of Southern Africa (DBSA):

Transfer of funds had been delayed because the legal division of DBSA wanted long term contracts between farmers and the buyers of milk. The matter had to be explained that the standard in the industry is to review the supply contract on an annual basis since such a contract is based on the proof of resources the farmer has regarding the number of cows, fodder flow planning situation and compliance certificates, amongst other things. Nonetheless, money has been received eventually but only in January 2014. During the period under review DBSA also organised a learning conference with grantees in order to improve delivery of the projective objectives.

2. Milk parlours and milking machines

Ms M. Hlka - incomplete and feeding troughs not yet constructed

Mr L. Mokoetele - working

Ms L. Moloi - incomplete, no feeding troughs and not yet tested

Mr P. Motlokoa - incomplete, no feeding troughs and not yet tested

Mr M. Makubo - working

Anton Gilfillan of Central Milk, the supplier of milking machines, reported that training was not part of his contract and had already spent R100 000 on repairing generators which were supplied as standby equipment. It was further reported farmers were not trained and no study was done while similar machines were working well in Swaziland, Mozambique and Malawi. There was no project leader and all funding was exhausted.

Resolved:

1. A person was needed to help farmers with milking machines on a contract basis.
2. Central Milk would keep spares at Nestle.
3. Central Milk would send more information to MGR re extra cost needed to train farmers on handling milking machines and mastitis and other outstanding matters.

3. Eskom

Electricity reticulation to the farms has been delayed because Eskom decided to review the quotations in 2014 because they said the validity period had expired. New quotations would be received in January 2014 after which Milk SA will pay connection fees dependent on the farmers readiness to pay a deposit of R10 500.00 per account as security.

4. Old Mutual

During the period under review visits were made with a representative of Old Mutual - Masisizane Fund to the farmers who needed funding their operations. Information was collected from farmers and also supplied by Milk SA. The following farmers are involved:

1. Mr Jan Zim
2. Mr L. Mokoete
3. Ms L. Moloji

Milk SA is only as a facilitator in this matter. The contract will be between the farmer and Old Mutual.

5. Fodder Flow Plan

Farmers have implemented the fodder flow plan as advised by the mentor appointed by Free State Agriculture. The plan was initially discussed with them and made it clear to the farmers that without a fodder flow plan and commitment to plant maize, heifers would not be delivered. Milk SA communicated with Free State Agriculture that those mentors Free State Agriculture appointed were not consultants of Milk SA and therefore anything they wanted from Milk SA should come via the department.

6. Heifer supply

Up to date only three farmers namely, Messrs Makoele (16), Makubo (14) and Zim (20) have been supplied with heifers. The delay is due to the following:

1. Scarcity of heifers.
2. Difficulties experience by farmers in getting potential suppliers and obtaining quotations.
3. Insufficient fodder flow on the farms.
7. Farm management record sheets. No change from the previous report.
8. Veterinary Services. The programme will be started with during January/February 2013.
9. Fodder flow assessment. Free State Agriculture has written reports on fodder planning for Mr Makubo, Mr Makoele and Mr Jan Zim. The report is currently being studied by the Work Group and our independent, experienced advisor.
10. Farmers have been advised to obtain quotations for heifers and given the names of potential sellers of heifers.
