Goal 4 - Make information produced by the IDF (Bulletins, Standards and Newsletters) available to levy payers and the general public

Achievements

Four Standards, two Press Releases and one News Bulletin were received during this quarter. The following Standards were received and all were forwarded to dairy industry representatives on SANCIDF:

IDF-231-ISO-16958-2015E - Milk, milk products, infant formula and adult nutritionals - determination of fatty acids.

IDF-232-ISO-19344-2015E- Milk and milk products-starter cultures probiotics and fermented products-quantification of lactic acid bacteria by flow cytometry.

IDF-234-ISO-20647-2015E - Infant formula and adult nutritionals - determination of total iodine.

IDF-235-ISO-20649-2015E - Infant formula and adult nutritionals - determination of chromium, selenium and molybdenum.

The following Newsbriefs and press releases were received during this quarter. They were all sent to representatives of processors and milk producers as well as to all SA representatives on Standing Committees.

Our concern about the increasing number of sustainability organizations viz GDAA, DSF and GSF.

IDF returned acceptable replies to all points.
