Goal 11 - To liaise with IDF re sustainability and environment by providing input from SA and communicating information from IDF to the SA industry.

Achievements

During this quarter, liaison with IDF was limited due to the World Dairy Summit taking place in Belfast. There were however, two requests from IDF. They were:

A request for input into a proposed New Work Item concerning a Dairy Sustainability Report.

This report would require local information that could link up with the Dairy Sustainability Forum's recently launched Global Indicators. These indicators are:

Water – Availability and Quality: a) Effluent management plan adopted to minimize impacts to water quality, and

b) Water Use Efficiency for production and processing is measured.

Biodiversity: A biodiversity plan is implemented to preserve, restore and improve biodiversity on-farm and across the supply chain.

Working Conditions: Farm/Facility Safety Plan is in place to ensure worker safety

Soil – Quality and Retention: Soil quality is maintained or improved by good management practices.

Soil Nutrients: Implementation of a Nutrient Management Plan to Enhance Production and reduce pollution.

The next stage will be to develop reporting guidelines for these but in the meantime they want to know if we have plans in place already and what they include. This is to ensure that what is already being done, is captured. This ties in well with the Milk SA Dairy Research Project where virtually every individual project is in fact aimed at improving sustainability and minimizing the impact on the environment.

2. Comments on a document titled "The Dairy Sector Safeguards Environmental Resources" This 7 page document still has to be finally approved by the Standing Committee for Environment and should be available soon for general consumption.
