**Project goals**

**Goal 1 - Deliberation of industry regulations relating food safety, product composition, metrological and related standards as well as voluntary industry related standards e.g. animal welfare and related matters**

***Achievements***

The Project management of the Regulations and Standards Project of Milk SA consulted regularly with the organised dairy industry with specific reference to the appointment of the DALRRD assignee and regulatory matters. Regular interaction between the project management and the Milk SA legal team continued during the third quarter. Matters highlighted relates to:

Extended Producer Responsibility (EPR) regulations under the National Environmental Management: Waste Act. Extended Producer Responsibility webinar for the dairy industry was held on 22 September 2020;

SABS SANS 1694 and interaction with the Livestock Welfare Co-ordinating Group as well as NSPCA to propose amendments to the standard;

Consumer Goods Ombud - enforcement of regulations on the dairy industry, in particular the secondary dairy industry;

The Buyer Power Regulations promulgated under the Competition Act, 89 of 1998;

BFAP - Agriculture and Agro-Processing Master Plan (AAMP).
