Project goals

Goal 1 - To maintain membership of IDF by paying the membership fees of IDF and IMP before 31 March 2024 at the best possible exchange rates

Achievements

The SA National Committee of IDF has to pay a membership fee as determined by IDF. The full membership fee for 2024 was €44 500 and was paid on 19 January 2024 at Rand value of R 927 325. South Africa is also a full member of the International Milk Promotion (IMP) group and its separate membership fee, was €1 220 at Rand value of R 21 022
